3 Reasons Why Everyone Should Have an Estate Plan

When a person dies without an estate plan, his or her assets are distributed according to Texas's law of "intestate succession" through the probate process. While Texas's intestate succession law assigns certain percentages of a person's estate to his or her heirs, it does not say specifically who gets what. As a result, in the absence of an

estate plan, uncertainty is all but guaranteed, and disputes are significantly more likely. Probate also involves costs and expenses that can be avoided with non-probate estate planning.

3. Comprehensiveness and Consistency

When you signed up for your retirement account or health savings account (HSA) at work, you likely selected a beneficiary who will receive the proceeds of your account in the event of your death. You may have also named beneficiaries to your bank accounts and insurance policies; and, if you own your home, the type of ownership you selected when you completed the title work could impact the distribution of your estate upon your death as well.
